Dear Washington Families,

As a parent/guardian of a student in Washington GT Magnet Elementary School, I am writing this letter to let you know that Washington GT Magnet Elementary, has been designated as a Targeted Support & Improvement Additional Targeted Support (TSI-AT) school by the North Carolina State Board of Education. Per ESSA Section 1111(d)(2), schools are identified as TSI-AT schools in North Carolina because one or more of the following subgroups received a subgroup performance grade score at or below the highest identified CSI-LP school's All Students group during the identification year; and is on the TSI-CU list for the subgroup(s) for the previous year. Subgroup performance scores are provided for the following subgroups: (1) Students with Disabilities, (2) Economically Disadvantaged, (3) Black, (4) White, (5) Hispanic, (6) Asian-Pacific Islander, (7) Multi-racial, and (8) English Learners. At our school, this subgroup is identified as students with disabilities. This subgroup of students continues to need additional targeted support. Our 2022-23 end of year data indicates that the students with disabilities subgroup did not meet proficiency, but did meet expected growth in both reading and math. Given that there is still a lot of work to be done, we will continue to work strategically to address the needs of all of our students, including those with disabilities.

This letter is to notify our parents and guardians of Washington Gifted and Talented Magnet Elementary School's intentions to improve educational outcomes for underperforming student subgroups and close achievement gaps for **all students**.

As a TSI-AT (ATSI) school, Washington Gifted and Talented Magnet Elementary School is required to develop an Additional Targeted Support and Improvement (ATSI) plan that specifically addresses how the school will improve outcomes for underperforming subgroups. The plan will also include strategies that our district or charter will employ to support Insert the name of the school's improvement efforts. The ATSI plan will address the following areas:

- Data-Driven Decision Making
- Student Support Services
- Family and Community Engagement

We have set the following goals for Washington GT Magnet Elementary this year:

The school implements a tiered instructional system that allows teachers to deliver evidence-based instruction aligned with the individual needs of students across all tiers.

- Instructional Teams develop standards-aligned units of instruction for each subject and grade level.
- The school will regularly communicate with parents/guardians about its expectations of them and the importance of the curriculum of the home (what parents can do at home to support their children's learning).

Our students need to experience higher achievement levels, but it will require hard work on the part of staff, students and families. Here are some strategies Washington GT Magnet Elementary will be implementing to improve student outcomes:

Strengthening Professional Learning Communities and their focus on data-driven instructional practices.

- Offering regular opportunities for teachers to collaborate in order to strengthen intervention supports.
- Participating in relevant Professional Learning to make instructional adjustments that meet the needs of our students.
- Utilizing data to align student supports with identified areas of need.
- Meeting regularly as an Intervention Team to ensure the consistent review of relevant student data.
- Actively progress monitoring goals within Individualized Education Plans to adapt instruction as necessary.
