After all applications have been considered and evaluated based upon enrollment criteria, **you will be notified no later than Friday, June 7th if you are or are not selected to attend via the parent and student email address listed on your application.**

- Students will begin asynchronous summer school coursework via NCVPS on **Tuesday, June 25, 2024**. Students will need to login to NCVPS on the first day of the course to confirm their NCVPS account and begin their coursework.
- Beginning Tuesday, June 25, 2024, students will be required to complete **5 hours of seat time** each week through Thursday, August 1, 2024. This will allow time for us to check in with students and their progress considering such a short time to complete an entire course.

2024 Summer School Eligibility and Academic Information

Population Served: Students enrolled at Crossroads FLEX for the 2023-2024 school year and Seniors needing to graduate in the 2023-2024 school year.

Students are admitted in the following priority order:

- Seniors (completing 4th year in Spring 2024) needing to graduate
- Juniors needing to be promoted and/or to support on-time graduation in Spring 2025
- Sophomores needing a class to be promoted
- Freshmen needing a class to be promoted
- To reduce course load during the student's most demanding pursuit season (documentation **must** be provided with the application, i.e. travel schedule, performance schedule)

Crossroads FLEX will use the NCVPS platform to deliver coursework.

** Only offered if failed during the 2023-2024 school year and required for promotion

There is no charge to students for 2024 Summer School courses, however the district does incur a cost for each student that enrolls in a course. As a result, students need to be committed to completing the course in its entirety during the summer school program.

Grade Reports:

1. Notification of summer school grade is sent to students at the end of the Summer School session in place of an official report card. Parents need to monitor progress on a daily basis via NCVPS Observer view.
2. Final exams are administered to students at the end of the course. If required, End of Course exams will be administered in person at Crossroads FLEX.
3. The grade earned in Credit Recovery Summer School will **not** count toward the GPA but will appear on the transcript. Students completing coursework on Edgenuity will receive Pass or Fail. All previous grades remain on the transcript and are calculated in the GPA.
4. The grade earned for repeat credit or first time credit courses through NCVPS will count toward the GPA and will appear on the transcript.

2024 Summer School Policies and Procedures

Technology Expectations:

Returning students will use their current laptop to complete coursework. All coursework is completed online.

Coursework Expectations:

Summer School coursework is assigned Monday through Friday virtually through the NCVPS Canvas platform. Students should familiarize themselves with Canvas, and reach out to the teacher for any assistance. The pace of the summer school curriculum moves quickly; it is imperative that students implement productive time management strategies and dedicate multiple hours each day to their coursework. Students should create a schedule that will help to avoid assignments being submitted late.

Students are expected to stay current with all assignments in their course. There will be close monitoring of their coursework completion status. Failure to keep up with assignments may increase their in-person seat time.

Summer School Attendance Policy:

One day in summer school is equivalent to approximately two weeks of traditional school. Thus, weekly check-in meetings with the FLEX summer school teacher are necessary and count toward the student's attendance. Failure to communicate with the summer school teacher and submit coursework on a consistent basis may increase a student's face time with the CFLEX summer school teacher. Seat time cannot be banked or prorated throughout the summer. **Failure to meet seat time for any one week of summer school will result in the student automatically being dropped from the course. Remember, summer school is optional, therefore you must meet academic and seat-time requirements.**

Conduct:

Misbehavior will not be tolerated within the summer school environment. The consequences of misbehavior may result in removal from summer school and subsequent loss of credit.

All Wake County Public School System rules regularly enforced during the school year are the same for students who attend the 2024 summer school session. Please refer to the 2023-2024 WCPSS and CFHS Student/Parent Handbook for specific information. Students are reminded of some important policies and guidelines.

1. Loss of technology and/or damage to technology will incur consequences, including potential loss of technology privileges for the upcoming school year.
2. Students at Crossroads FLEX and NCVPS adhere to a strict Honor Code. Cheating and/or plagiarism are a violation of academic integrity and will not be tolerated. Consequences for integrity violations include parent contact, resubmission of assignments, and/or grading penalties. Repeated occurrences may result in withdrawal from the course.
3. Major infractions, as determined by the administrator, may result in removal from the Summer School program and/or suspension.
